WHEREAS, the KSU Bids and Awards Committee (BAC) was tasked to evaluate the Purchase Request No. 100-01-0107, for the procurement of [ ] goods [ ] consulting services [ ] civil works;
WHEREAS, in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions stated in the RFQ, the BAC, with the assistance of the Technical Working Group (TWG), has undertaken the following Post Qualification proceedings, as applicable:
[ ] 1. The BAC has determined whether KSU is entering into a contract with a capable Supplier, Consultant, or Contractor by requiring the submission of applicable eligibility, technical and financial documents with reference to Appendix A of Annex H, 2016 R-IRR of RA 9184 of the Documentary Requirement for AMP.
