INVITATION TO BID FOR PROCUREMENT OF VARIOUS CY 2021 IGI-FUNDED LABORATORY EQUIPMENT INCLUDING FURNITURE AND FIXTURES

1. The Kalinga State University, through the Internally Generated Income (IGI) Fund for CY 2021 intends to apply the sum of Six Million, Seven Hundred Thousand, Three Hundred Seventy-Seven Philippine Pesos (Php 6,700,377.00) being the ABC to payments under the contract for each lot of the Project "Procurement of Various CY 2021 IGI-Funded Laboratory Equipment including Furniture and Fixtures"/ IB_Goods_2021-09-065. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

Partial bids are allowed. All Goods are grouped into lots listed above. Bidders shall have the option of submitting a proposal on any or all lots. If the Bidder opts to bid for more than one lot, each set of technical requirements shall be submitted. Evaluation and award of contract will be undertaken per lot basis; however, for bidder that bids to more than one lot and determined to have the Lowest Calculated Responsive Bid per lot shall be awarded only one contract.

- 2. The Kalinga State University now invites bids for the above Procurement Project. Delivery of the Goods is required within Ninety (90) calendar days upon receipt of the Purchase Order. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, any of the following:
 - **a.** A contract similar to this project, equivalent to at least fifty percent (50%) of the ABC for each or total lots; **or**
 - **b.** The prospective bidders should have completed at least 2 similar contracts, the aggregate contract amounts should be equivalent to at least 50% of the ABC for each lot or total lots. The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.

The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).

- **3.** Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- **4.** Prospective Bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below during *office hours from 9 am to 4 pm*.

A complete set of Bidding Documents may be acquired by interested Bidders on September 14, 2021 (Tuesday) until 10 am of October 4, 2021 (Monday) from the given address and websites below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of not more than Ten Thousand Philippine Pesos (Php 10,000.00) as prescribed in the Guidelines for the sum of the ABC of all lots as stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through electronic means. For online payment, kindly coordinate with the BAC Secretariat for issuance of the KSU bank account details.
- 6. The Kalinga State University will hold a Pre-Bid Conference on September 22, 2021 (Wednesday), 10 am at the BAC Conference Room, Procurement Management Office, Administration Building, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga, and/or through video conferencing or webcasting via Google Meet Platform at the link: meet.google.com/hus-qwtj-aka, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 10 am on October 4, 2021 (Monday). Late bids shall not be accepted.
- **8.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on 10:01 am on October 4, 2021 (Monday) at the given address below and/or via Google Meet Platform at the link: meet.google.com/crh-kcwj-gje. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- **10.** Bidders should comply with the applicable provisions of Section 23.4.1.1 of 2016 Revised IRR of R.A. 9184 (Eligibility Criteria for Procurement of Goods) and with a modified set of requirements integrating eligibility documents and criteria for procurement of goods as provided in Annex D of the 2016 revised IRR of RA No. 9184.
- 11. The Kalinga State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the Contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
