## **Invitation to Bid for Completion of Motorpool- Bulanao Campus**

- 1. The Kalinga State University (KSU), through the General Appropriations Act under the Regular Agency Fund CY 2020 intends to apply the total sum of Fourteen Million, Five Hundred Sixty-Three Thousand, One Hundred Eight Philippine Pesos (Php 14,563,108.00) being the Approved Budget for the Contract (ABC) to payments for 2 Lots under the Contract for Completion of Motorpool- Bulanao Campus/ IB\_CivilWorks\_2020-06-034. Bidders shall have the option of submitting a proposal on a lot or all lots. If the bidder opts to bid for more than one lot, only one set of eligibility requirements shall be submitted. Evaluation and award of contract will be undertaken per lot basis; however, for a bidder that bids to more than one lot and determined to have the Lowest Calculated Responsive Bid should be awarded only one contract. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Kalinga State University now invites bids for the Completion of Motorpool- Bulanao Campus as follows:

Completion of the Works for Lot 1: Completion of Motorpool Building is required within One Hundred Eighty-Three (183) calendar days, and Delivery Schedule for Lot 2: Procurement of Equipment is required within Seventy-Nine (79) calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- **4.** Interested bidders may obtain further information from **Kalinga State University** and inspect the Bidding Documents at the address given below from **8 am to 5 pm office hours**.
- 5. Interested bidders may acquire a complete set of Bidding Documents on June 11, 2020 (Thursday) until 10:00 AM of July 1, 2020 (Wednesday) from the address below and upon payment of the applicable fee for the Bidding Documents, under the latest Guidelines issued by the GPPB, in the appropriate amount indicated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity at <a href="https://ksu.edu.ph/good-governance/invitebid">https://ksu.edu.ph/good-governance/invitebid</a>, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For bidders who wish to purchase the bid documents, please notify the BAC Secretariat at the contact details located at Paragraph No. 10 of this Invitation to Bid for issuance of the University's bank account where you could deposit the payment. Upon a successful transaction, the University's Cashiering Unit will issue the corresponding official receipt.

The Kalinga State University will hold a Pre-Bid Conference through Zoom App video-conferencing (ID: 623 224 9110 and Password: ksu103) on June 19, 2020 (Friday), 10:00 AM at Alumni Center, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga, which shall be open to prospective bidders.

7. The BAC Secretariat must duly receive bids at the address below on or before July 1, 2020 (Wednesday) at 10:00 AM. The KSU has no system yet for electronic submission and receipt of bids, hence manual submission and through courier (applicable to bidders outside the Kalinga Province) is still the new normal. This mode of submission complies with GPPB Resolution No. 09-2020 re "Approving Measures for the Efficient Conduct of Procurement Activities during a State of Calamity, or Implementation of Community Quarantine or Similar Restrictions." All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause Error! Reference source not found.

Bid opening shall be on 10:01 AM of July 1, 2020 (Wednesday) at Alumni Center, KSU-Main Campus, National Highway, Purok 6, Bulanao, Tabuk City, Kalinga. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. The Bid Opening shall be witnessed by bidders, who are outside the province and availed the bid documents, via Zoom App (ID: 623 224 9110 and Password: ksu103). Late bids shall not be accepted.

- **8.** Bidders should comply with the applicable provisions of Section **23.4.2** of the IRR of R.A. 9184 and with a modified set of requirements integrating eligibility documents and criteria for infrastructure projects as provided in Annex E of the 2016 IRR of R.A. 9184, or the **Contract Implementation Guidelines for the Procurement of Infrastructure Projects**.
- **9.** The **Kalinga State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time before contract award per Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
