A BAC RESOLUTION DECLARING CSD ENGINEERING AND CONSTRUCTION AS POST QUALIFIED AND RECOMMENDING AWARD OF CONTRACT

RESOLUTION NO. 733, S. 2017

(CIVIL WORKS)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) posted in the PhilGEPS website (https://www.philgeps.gov.ph) on October 31, 2017 to November 7, 2017 the Invitation to Bid (IB) for Completion of Library Building - Rizal Campus (Ref. No. 264004010100019) with an Approved Budget for the Contract (ABC) amounting to Nine Million, One Hundred Thirty-three Thousand, Forty-seven Philippines Pesos and Twenty-eight Centavos (Php 9,133,047.28) and posted the same at the KSU website (http://ksu.edu.ph), and conspicuous place at the premises of the University continuously for seven days;

WHEREAS, in response to the said posting/advertisement, four (4) bidders have browsed/read the opportunity at the PhilGEPS website namely: AZ General Merchandizing, Shama Homes Construction, R.B. Alcazar Construction Corp., and Remnant Builders, while three (3) bidders-CSD Engineering and Construction, I.P. Lacwasan Construction and Development Corporation, and DEKM Construction read the IB at the KSU websites and at the premises of the University;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference together with the bidder's representatives of CSD Engineering and Construction, and I.P. Lacwasan Construction and Development Corporation on November 8, 2017 whereupon Supplemental Bid Bulletin No. 1 and 2 dated November 9 and 11, 2017 were issued regarding amendments and clarifications in the bid documents, technical specifications and PCAB license;

WHEREAS, during the Receipt of Bids on November 20, 2017, DEKM Construction's bid was declared late and was not accepted by the BAC pursuant to Sections 25.5 and 25.6 of the IRR-RA 9184, while CSD Engineering and Construction was rated ineligible due to patently erroneous Statement of Ongoing and Completed Government and Private Contracts whereby the bidder's representatives waived their right to file a motion for reconsideration;

WHEREAS, the BAC re-published the IB on November 21-28, 2017 at the required sites whereby FDG Consulting has browsed/read the opportunity at the PhilGEPS website while CSD Engineering and Construction read the IB at the KSU websites and at the premises of the University;

WHEREAS, the BAC and TWG-Infra conducted a Pre-bid Conference on November 29, 2017 whereupon no prospective bidders have attended and no Supplemental Bid was issued;

WHEREAS, during the Receipt of Bids on December 11, 2017, CSD Engineering and Construction submitted its bid envelope containing eligibility, technical and financial components after it availed a bid document on December 6, 2017;

WHEREAS, the BAC, upon recommendation of the TWG-Infra, declared that CSD Engineering and Construction was "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the financial bid envelope, to declare the bid of CSD Engineering and Construction in the amount of Nine Million Ninety Eight Thousand Nine Hundred Sixteen Philippine Pesos and Five Centavos (Php9,098,916.05) as the Single Calculated Bid (SCB) As Read subject to the conduct of post qualification evaluation;
