	the Kalinga State University (KSU) seeks to attain economy and efficiency in all aspects of its procurement operations by resorting to the above-mentioned Alternative Method of Procurement consistent with Rule XVI of the Implementing Rules and Regulations of Republic Act No. 9184;
WHEREAS,	the Bids and Awards Committee was tasked to evaluate the <b>Purchase Request No.</b> Lolk - 09-0005 for the purchase of goods;
WHEREAS,	said items are included and conformed to the approved budget of the end-user's Project Procurement Management Plan (PPMP), and KSU Annual Procurement Plan (APP) for CY 2017;
WHEREAS,	the following are the <b>reasons</b> for the purchase of said goods:
1.	That <b>the amount involved is above Php200,000.oo and equals to or below Php1,000,000.oo</b> which is an small amount to justify the conduct of public bidding and within the thresholds prescribed in Annex "H" of the 2016 IRR of R.A. 9184 for SUCs.
2.	The goods, which are "ordinary or regular office supplies," are not available/offered/out of stock at the DBM Procurement Service.
3.	That Request for Quotations (RFQs) shall be posted for three (3) calendar days in the PhilGEPS website, KSU website and at conspicuous place reserved for posting of KSU bidding opportunities.
4.	The BAC shall send and obtain RFQs to at least three (3) suppliers of known qualifications.
5.	That procurement of these goods do not fall under the prohibition on "Splitting of Government Contracts."
6.	KSU has ensure that the objectives and purpose of the contract do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure.
7.	That the BAC shall validate the <b>technical, legal and financial capability of the supplier(s) by requiring the submission of relevant documents</b> or through other means prior to recommendation of award to the HOPE.
NOW THEREFORE, we the Members of the BAC, hereby RESOLVE AS IT HEREBY RESOLVED:	
to recommend Alternative Method of Procurement through Shopping as provided in Section 52.1(b) and Consolidated Guidelines for the Alternative Methods of Procurement of the Annex "H" of the Revised IRR of R.A. 9184 for the above-cited goods/services; and	
	recommend the award and approval by the KSU President of this Resolution and Purchase Order to the nafide Supplier(s) indicated in the Abstract of RFQ/Canvass.
