	CONSULTING SERVICES
1	the Kalinga State University (KSU) seeks to attain economy and efficiency in all aspects of its procurement operation by resorting to the above-mentioned Alternative Method of Procurement consistent with Rule XVI and Annex "B" of the Implementing Rules and Regulations of Republic Act No. 9184;
WHEREAS, t	the KSU Bids and Awards Committee was tasked to evaluate the <b>Purchase Request No.</b> $200 - 01 - 0011$ , for the procurement of consulting services;
	he services of consultant/s may be engaged by KSU as Procuring Entity for government projects or related activities of sucl magnitude and/or scope as would require a level of expertise or attention beyond the optimum in-house capability of the procuring entity concerned and consistent with the Government's policy not to compete with the private sector;
	consultant/s shall be hired on the basis of their proven expertise, experience and capability, under certain condition cost may be included as a factor in the selection of consultants;
WHEREAS, t	the following are the grounds for the procurement of said services:
1.	In case of individual consultants hired to do work that is $[\ ]$ highly technical or proprietary; or $[\ ]$ primarily confidential or policy determining, where trust and confidence are the primary consideration for the hiring of the consultant:
	That the term of the individual consultants shall, at the most, be on a six-month basis, renewable at the option of the appointing HoPE, but in no case shall exceed the term of the latter.
3.	That procurement of these services, which involve Construction General forms of Government Contracts." His way from Blog.
4.	KSU has ensure that the objectives and purpose of the contract do not constitute an unnecessary, excessive, extravagant or unconscionable expenditure.
5.	That the HOPE through the BAC has determined whether KSU is <b>entering into a contract with technically, legally and financially capable consultant(s) by requiring the submission of relevant documents</b> or through other means.
