KALINGA STATE UNIVERSITY BIDS AND AWARDS COMMITTEE

A BAC RESOLUTION DECLARING SLCRB AND RECOMMENDING APPROVAL

RESOLUTION NO. 182, S. 2017
(INFRA)

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University advertised in the PhilGEPS website, KSU website, BAC Bulletin Board, and conspicuous place at the premises of the University the Invitation to Bid of the Project, Construction of Perimeter Fencing - Bulanao Campus continuously from March 1-21, 2017;

WHEREAS, in response to the said advertisement, only E.T. Amilia Construction has purchased the bidding documents and submitted its bid on March 21, 2017;

WHEREAS, during the Evaluation of Bids on the same day, March 21, 2017, the lone bidder was declared "ineligible" for an erroneous entry in one of the paragraphs of the Omnibus Sworn Statement [paragraph 8(iv)] and was accordingly corrected after granting their motion for reconsideration;

WHEREAS, when the Bid Opening resumed on March 23, 2017, E.T. Amilig Construction was declared "eligible" as to technical documents, and "complying" as to financial proposal, subject for submission of some documents including license ID, certificate of key personnel and affidavit for clarificatory purposes;

WHEREAS, during the duration of post qualification process, the lone bidder complied with the submission of clarificatory documents, and the TWG submitted his report with findings that the lone bidder has not meet the fifty percent (50%) of the ABC in the Single Largest Completed Contract (SLCC);

WHEREAS, the body deliberated and resolved that for prospective bidders registered under either Small A or Small B category that does not have a previously completed similar contract, are allowed to participate in the procurement activity provided that the cost of the contract being bid out is not more than fifty percent (50%) of its ARCC as provided by Section 23.4.2.4 of the 2016 IRR of RA 9184;

NOW, THEREFORE, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**

to declare E.T. Amilig Construction as Post Qualified, based on the above findings, being the bidder with the Single Lowest Calculated and Responsive Bid (SLCRB) in the Total Amount of Two Million, Six Hundred Seven Thousand, Four Hundred Thirty-Three Philippine Pesos and Forty-Nine Centavos (Php 2,607,433.49) for Construction of Perimeter Fencing at Bulanao Campus; and

to recommend for approval by the President of the Kalinga State University of an award and the foregoing findings.
