**A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND  
RECOMMENDING FOR AWARD OF CONTRACT FOR THE NEGOTIATED  
PROCUREMENT FOR CONSTRUCTION OF BAMBOO NURSERY IN  
RIZAL CAMPUS**

**BAC Resolution No. 1057  
Series of 2024**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Notice of Negotiated Procurement in the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on **August 9-15, 2024**, for the conduct of Negotiated Procurement through Two-failed Biddings modality on the **Negotiated Procurement for Construction of Bamboo Nursery in Rizal Campus** with an Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Eighty-Seven Thousand Nine Hundred Eleven and 15/100 Philippine Pesos (Php 1,487,911.15)** sourced from **Regular Agency Fund for CY 2024** and posted the same at the KSU Website (<https://ksu.edu.ph/bid/negotiated-procurement-construction-bamboo-nursery-rizal-campus-0>), and conspicuous place at the premises of the University Campuses, continuously for three (3) calendar days after the following failed biddings were conducted:

WHEREAS, in response to the said posting/advertisement, **one (1) prospective bidder**, namely: ADEB's Construction browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, during the **Receipt and Opening of Bids on August 15, 2024 @ 10 am**, ADEB's Construction submitted its proposals whereupon the BAC declared ADEB's Construction as **"eligible"** and passed the technical evaluation of the bidding, and the bid as calculated is as follow:

WHEREAS on August 15, 2024, the TWG-INFRA submitted their report recommending to the BAC for declaration of the lone bidder as the Single Calculated and Responsive Bid;






**WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED**, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Project, **hereby recommends for approval by the University President to declare the bid of Adeb's Construction as Single Calculated Responsive Bid and to award the contract amounting to One Million Four Hundred Eighty-Six Thousand Five Hundred Fifteen and 85/100 Philippine Pesos (Php 1,486,515.85) for the Negotiated Procurement for Construction of Bamboo Nursery in Rizal Campus.**
