



A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF A CONTRACT FOR THE PROCUREMENT OF ELECTRICAL POWER SYSTEMS LABORATORY TRAINER PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 200

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on March 1 - 25, 2024, for the bidding of Procurement of Electrical Power Systems Laboratory Trainer with an Approved Budget for the Contract (ABC) amounting to Twenty-Six Million, Five Hundred Thousand Philippine Pesos (Php 26,500,000.00) sourced from Trust Receipt Fund (TRF) for CY 2024 and posted the same at the KSU Website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, twelve (12) **prospective bidders**, namely State Alliance Enterprises Inc., MDCS Mechanical Design and Control System, Hytec Power, Inc., Prince Valiant Int'l Corp., Velca Equipment and Engineered Products, Inc., Hexatronics Marketing, Digital Manufacturing Solutions Inc., Multi-Electric Systems, Inc., Greenlight Power, Inc., North Flash Power and Builds Inc., www construction and Big One Solutions, Inc. browse/read the opportunity at the sites mentioned above, and downloaded the bidding documents;

WHEREAS, the BAC Secretariat issued **Supplemental Bid/Bulletin (SBB) No. 01** dated March 14, 2024 to amend the contents of bidding documents particularly to the project requirement.

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Electrical Related Supplies and Equipment conducted the **Pre-bid Conference** simultaneously via Google Meet Link: meet.google.com/fsu-eaby-pji, with the bidder's representatives on **March 13, 2024, @ 01:00 pm**;

WHEREAS, as per records of the BAC Secretariat, only one (1) bidder, namely: State Alliance Enterprises Inc, purchased the bidding documents on March 13, 2024;

WHEREAS, one (1) bidder, namely: State Alliance Enterprises Inc., had submitted its bidding proposal containing the technical and financial documents before the scheduled time;

WHEREAS, during the **Opening of Bids** on **March 25, 2024**, the BAC, upon the recommendation of the TWG for Electrical Related Supplies and Equipment, declared the bids of State Alliance Enterprises, Inc. as **"eligible"** and passed the technical evaluation of the bidding;

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of State Alliance Enterprises, Inc. as **"complying"** and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:




