



**A BAC RESOLUTION DECLARING POST-QUALIFIED BIDDER AND RECOMMENDING AWARD OF CONTRACT FOR LOT 1 AND LOT 2 FOR THE PROJECT “PURCHASE AND DELIVERY OF OFFICE SUPPLIES, MATERIALS AND EQUIPMENT INCLUDING JANITORIAL AND CONSUMABLES FOR CY 2023 – SECOND BIDDING” IN COMPLIANCE TO REPUBLIC ACT NO. 9184 AND ITS 2016 REVISED IMPLEMENTING RULES AND REGULATIONS**

**WHEREAS**, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website: <https://notices.philgeps.gov.ph/> on **March 30, 2023 to April 24, 2023** for the rebidding of the **Purchase and Delivery of Office Supplies, Materials and Equipment including Janitorial and Consumables for CY 2023 – Second Bidding** with a total Approved Budget for the Contract (ABC) amounting to **Four Million, Five Hundred Four Thousand, Six Hundred Sixty-Eight Philippine Pesos and 63/100 (Php 4,504,668.63)** sourced from **Regular Agency Fund for CY 2023** and posted the same at the KSU Website: <https://ksu.edu.ph/bid/purchase-and-delivery-office-supplies-materials-and-equipment-including-janitorial-and-0>, and conspicuous place at the premises of the University Campuses, continuously for **seven (7)** calendar days after its first failed bidding conducted for the period February 6-28, 2023.

**WHEREAS**, in response to the said posting/advertisement, **eight (8) prospective bidders**, namely: GNF General Merchandise, Lighthouse Cooperative, Rhoze Jonah's Enterprises, Asiaprime Commodities Corporation, Summit Pacific Philippines Incorporated, Ohana Tailoring, Ocean De Azul Hospitality School Incorporated and Need Ink Sales & Services browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

**WHEREAS**, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWG) for IT and related Supplies and Equipment and TWG for Goods conducted the **Pre-bid Conference** including **online** via Google Meet link: [meet.google.com/tgy-pivx-icz](https://meet.google.com/tgy-pivx-icz) with the prospective bidders and bidder's representatives on **April 11, 2023 @ 10:00 am** whereupon **Supplemental Bid/Bulletin (SBB) No. 01 dated April 14, 2023, SBB No. 2 dated April 17, 2023 and SBB No. 3 dated April 21, 2023** were issued to amend the contents of bidding documents including the schedule of the bid opening;

**WHEREAS**, as per records of the BAC Secretariat, only **two (2) bidder purchased the bidding documents**, namely: Kalinga Printing Press and General Merchandise and JM Ibañez Enterprise;

**WHEREAS**, both prospective bidders submitted their bid documents containing the technical and financial documents before the scheduled time;

**WHEREAS**, during the **Opening of Bids on April 24, 2023 @ 10:01 am**, the BAC, upon the recommendation of the TWG for IT related Supplies and Equipment and TWG for Goods, declared the bids of JM Ibañez Enterprise, as **“eligible”** and passed the technical evaluation of the bidding for Lot 1 & Lot 2. The bid proposal of Kalinga Printing Press and General Merchandise was declared as **“ineligible”** due to expired Tax Clearance.


**WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED** that the Bids and Awards Committee hereby recommends to:

1. **Declare the bids of JM Ibañez Enterprise as Single Calculated and Responsive Bid (SCRB) and to recommend for approval by the Board of Regents through the University President an award of contract in the total amount of Four Million, Thirteen Thousand, Five Hundred TTwnety-Nine Philippine Pesos (Php 4,013,529.00) pursuant to Section 36 of the revised IRR of RA No. 9184; and**
2. **Tasked the TWG for Agricultural Supplies to Conduct Mandatory Review for the Lot 3 and Resort to Negotiated Procurement through Two Failed Bidding.**
