A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF A CONTRACT FOR THE PURCHASE AND DELIVERY OF ONE UNIT SPORTS UTILITY VEHICLE (SUV) FOR KALINGA STATE UNIVERSITY PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 470
Series of 2023**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on June 7, 2023, to June 14, 2023, for the bidding of **Purchase and Delivery of One Unit Sports Utility Vehicle (SUV) for Kalinga State University** with an Approved Budget for the Contract (ABC) amounting to **Two Million Seven Hundred Thousand Philippine Pesos (Php 2,700,000.00)** sourced from Internally Generated Fund (IGF) for CY 2023 and posted the same at the KSU Website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, three (3) **prospective bidders**, namely: Nissan Commonwealth, Inc., Elite North Autocars, Inc., G. Arabia Platinum Construction and Development Co., browse/read the opportunity at the sites mentioned above, and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Vehicles (TWG-Vehicles) conducted the **Pre-bid Conference** simultaneously via Google Meet Link: **meet.google.com/agq-cesw-five**, with the bidder's representatives on **June 15, 2023, @ 10 am** whereupon **Supplemental Bid/Bulletin (SBB) No. 01** dated 19 June 2023 was issued to amend the contents of bidding documents, particularly on Item and Description of Technical Specifications of the project;

WHEREAS, as per records of the BAC Secretariat, only one (1) bidder, namely: Toyota Isabela, Inc., purchased the bidding documents on June 26, 2023;

WHEREAS, one (1) bidder, namely: Toyota Isabela, Inc., had submitted its bidding proposal containing the technical and financial documents before the scheduled time;

WHEREAS, during the **Opening of Bids on June 27, 2023**, the BAC, upon the recommendation of the TWG for Vehicles, declared the bids of Toyota Isabela, Inc. as **"eligible"** and passed the technical evaluation of the bidding;

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Toyota Isabela, Inc. as **"complying"** and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:



WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Vehicles, hereby **recommends for approval by the University President to declare the bid of Toyota Isabela, Inc. as Single Calculated Responsive Bid and to award the contract amounting to Two Million, Six Hundred Twenty Thousand Philippine Pesos (Php 2,620,000.00) for the Purchase and Delivery of One Unit of Sports Utility Vehicle (SUV) for Kalinga State University.**

RESOLVED FINALLY to post this Resolution at the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.
