WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website: https://notices.philgeps.gov.ph/ on April 24,2024 to May 2, 2024 for the bidding of the Procurement of Equipment for Completed Projects - Fabrication Laboratory - Second Bidding with a total Approved Budget for the Contract (ABC) amounting to Three Million Eight Hundred Sixty Thousand Philippine Pesos (Php 3,860,000.00) sourced from Regular Agency Fund (RAF) for CY 2024 and posted the same at the KSU Website: https://ksu.edu.ph/bid/procurementequipment-completed-projects-%E2%80%93-fabrication-laboratory-%E2%80%93-second-bidding conspicuous place at the premises of the University Campuses, continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, twenty-five (25) prospective bidders, namely: Xitrix Computer Corporation, Joneco Tech Marketing Corp., Tarlac Mac Enterprises, Inc. Doing Business Under the Name and Style of First AC Megasaver and First MAC Megasaver, DCI Int'l. I.T. Solutions and Services Corporation, Atarashii Technologies International, Cosmotech Philippines, Inc., Terabit Computer Systems Corporation, Digital Manufacturing Solutions Inc., Avtech Information Technology Solutions, REDGUTZ Trading, Innove Communications, Inc., Gabigroup Inc., Alejandra Enterprises, Hundredfold Trading Corp., Hytec Power, Inc., Micromedia Technologies, NSB Engineering Design and Fabrication, Masangkay Computer Center, AEC Techno World, J and G General Merchandise, Lase Laboratory Equipment Trading, Aspen Multi-System Corporation, GNF General Merchandise, Big One Solutions, Inc., American Technologies Inc., browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWG) for IT and related Supplies and Equipment conducted the Pre-bid Conference via Google Meet link: meet.google.com/tpy-tyoy-dja with the prospective bidders and bidder's representatives on May 2, 2024 @ 10:00 am after which a Supplemental Bid/Bulletin (SBB) No. 01 dated May 7, 2024, was issued to amend the contents of bidding documents specifically the Technical Specifications;

WHEREAS, only one (1) prospective bidder namely: Digital Manufacturing Solutions. Inc. have purchased the bidding documents amounting to Five Thousand Pesos (Php 5,000.00) with an Official Receipt No. 877197 dated May 10, 2024;

WHEREAS, the lone bidder namely: Digital Manufacturing Solutions, Inc. submitted their bid proposals containing the technical and financial documents on May 13, 2024;

WHEREAS, during the Opening of Bids on May 14, 2024 @ 10:01 am, the BAC, upon the recommendation of the TWG for IT related Supplies and Equipment, declared the bids of Digital Manufacturing Solutions, Inc. as "eligible" and passed the technical evaluation of the bidding.

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Digital Manufacturing Solutions, Inc. as "complying," in the amount of Three Million, Eight Hundred Fifty-Five Thousand Philippine Pesos (PHP 3,855,000.00) and further proclaimed as the Single Calculated Bidder and the bids as calculated are as follows:
