A BAC RESOLUTION DECLARING POST-QUALIFIED BIDDER AND RECOMMENDING AWARD OF CONTRACT FOR THE PROJECT "PURCHASE AND DELIVERY OF SUPPLIES, MATERIALS AND EQUIPMENT NOT AVAILABLE AT DBM-PS FOR CY 2024" IN COMPLIANCE TO REPUBLIC ACT NO. 9184 AND ITS 2016 REVISED IMPLEMENTING RULES AND REGULATIONS

#### **BAC Resolution No. 939** Series of 2023

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website: https://notices.philgeps.gov.ph/ on December 1-13, 2023 for the bidding of the Purchase and Delivery of Supplies, Materials and Equipment not Available at DBM-PS for CY 2024 with a total Approved Budget for the Contract (ABC) amounting to Four Million Seven Hundred Eighty Thousand One Hundred Ten Philippine Pesos and Eighteen Centavos (PHP 4,780,110.18) sourced from Regular Agency Fund for CY 2024 and posted the same at the KSU Website: https://ksu.edu.ph/bid/purchase-and-delivery-supplies-materials-and-equipment-not-availableps-dbm-cy-2024, and conspicuous place at the premises of the University Campuses, continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, eleven (12) prospective bidders, namely: Packware Phils., Inc., GRSoriano Consumer Goods Wholesaling, , GNF General Merchandise, Kalinga Printing Press and General Merchandise, Bides Marketing, Juan Book Store, Lighthouse Cooperative, Isabela-Livelihood Center and General Merchandise, Doña Alejandra Incorporated, Pronet Systems Integrated Network Solution Incorporated, ESJ General Merchandise and Lase Laboratory Equipment Trading browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWG) for IT and related Supplies and Equipment and TWG for Goods conducted the Pre-bid Conference online via Google Meet link: meet.google.com/iox-mdjq-reu with the prospective bidders and bidder's representatives on December 14, 2023 @ 10:00 am after which Supplemental Bid/Bulletin (SBB) No. 01 dated December 19, 2023, was issued to amend the contents of bidding documents;

WHEREAS, as per records of the BAC Secretariat, only four (4) bidders purchased the bidding documents, namely: Kalinga Printing Press and General Merchandise for Lot 1 and Lot 2, GNF General Merchandise for Lot 1, ESJ General Merchandise for the three (3) lots and GRSoriano Consumer Goods Wholesaling for the three (3) lots;

WHEREAS, only three (3) prospective bidders submitted their bid documents containing the technical and financial documents before the scheduled time namely: Kalinga Printing Press and General Merchandise for Lot 1, GNF General Merchandise for Lot 1, and GRSoriano Consumer Goods Wholesaling for the three (3) lots;

WHEREAS, during the Opening of Bids on December 27, 2023 @ 10:01 am, the BAC, upon the recommendation of the TWG for IT related Supplies and Equipment and TWG for Goods, declared the bids of

GRSoriano Consumer Goods Wholesaling and Kalinga printing Press and General Merchandise as "eligible" and passed the technical evaluation of the bidding.

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of GRSoriano Consumer Goods Wholesaling as "complying," and further proclaimed as the Single Calculated Bidder and the bids as calculated are as follows:

WHEREAS, the TWG for IT-related supplies and equipment and TWG for Goods, upon the conduct of Post-Qualification Evaluation by the composite Post Qual Team on December 28, 2023, recommended to the BAC to declare the bid of GRSoriano Consumer Goods Wholesaling as complying and declared as the Single Calculated and Responsive Bid (SCRB) for the project Purchase and Delivery of Supplies, Materials and Equipment not Available at DBM-PS for CY 2024;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED that the Bids and Awards Committee hereby recommends to declare the bids of GRSoriano Consumer Goods Wholesaling as Single Calculated and Responsive Bid (SCRB) and to recommend for approval by the Board of Regents through the University President an award of contract in the total amount of Four Million Four Hundred Ninety-Eight Thousand Four Hundred Seventy-Eight Philippine Pesos and Eight Centavos (PHP 4,498,478.08) pursuant to Section 36 of the revised IRR of RA No. 9184:
