



**A BAC RESOLUTION DECLARING POST-QUALIFIED BIDDER AND  
RECOMMENDING AWARD OF CONTRACT FOR THE PROJECT  
“UPGRADING OF LABORATORY FACILITIES OF THE COLLEGE OF  
AGRICULTURE – LOT 1- LABORATORY EQUIPMENT” IN COMPLIANCE  
TO REPUBLIC ACT NO. 9184 AND ITS 2016 REVISED IMPLEMENTING  
RULES AND REGULATIONS**

**BAC Resolution No. 580  
Series of 2024**

**WHEREAS**, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website: <https://notices.philgeps.gov.ph/> on **July 19, 2024 to August 12, 2024** for the bidding of the **Upgrading of Laboratory Facilities of the College of Agriculture** with a total Approved Budget for the Contract (ABC) amounting to **Three Million Philippine Pesos (Php 3,000,000.00)** sourced from **Trust Receipt Fund (TRF) for CY 2024** and posted the same at the KSU Website: <https://ksu.edu.ph/bid/upgrading-laboratory-facilities-college-agriculture> and conspicuous place at the premises of the University Campuses, continuously for **seven (7)** calendar days;

**WHEREAS**, in response to the said posting/advertisement, forty-three (43) prospective bidders, namely: Science Gear Enterprises, LB2 Laboratory Supplies, Medical Center Trading Corporation, GRSoriano Consumer Goods Wholesaling, Diamed Enterprise, Alcaport trade, Grit Laboratory Furnitures and Equipment Corporation, Metos Offshore Inc., Krypton International Resources Sales & Services Inc., Aspen Multi-System Corporation, Endure Medical, Inc., Prince Valiant International Corporation, Almonte Enterprise, Diamond Industrial Systems Provider, Inc., Sciencestar Corporation, Gecar Machine Solutions Inc., Alvtchnologies Philippines, Incorporated, Noveaulab Asia Corp., State Alliance Enterprises, Inc., Mt. Zion Scientific, Inc., Rainphil, Inc., Rayto Medical Drug, Chemoscience Phils, Inc., Pro Maintech Consultancy Inc., Humil International Trading, ITS Science (Phil), Inc., Mars Laboratory Instruments Center, Redgutz Trading, Siccion Marketing, Inc., Vitaline Healthcare Inc., MMJ Biosystems Philippines, Inc., DKSH Philippines Inc., RUF Brothers Construction Corporation, Hytec Power Inc., Goldquest Biotechnologies, Inc., Thy Grace Medical Supply and Services, Advira Trading Corporation, Molave Trading Corporation, Hexatronics Marketing, Speed Scientific & Laboratory Supply, Andson Educational Resources Inc., Rmeltgarejo Pharma nad Medical Supplies Trading and Shidmadzu Philippines Corporation browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

**WHEREAS**, the Bids and Awards Committee (BAC) and the Technical Working Groups (TWG) for IT and related Supplies and Equipment conducted the **Pre-bid Conference** via Google Meet link: [meet.google.com/gzh-yfue-zqz](https://meet.google.com/gzh-yfue-zqz) with the prospective bidders and bidder's representatives on **July 31, 2024 @ 10:00 am** after which a **Supplemental Bid/Bulletin (SBB) No. 01 dated August 2, 2024**, was issued to amend the contents of bidding documents specifically the Delivery Period;

**WHEREAS**, two (2) prospective bidder namely: Prince Valiant International Corporation and Grit Laboratory Furnitures and Equipment Corporation have purchased the bidding documents amounting to Five Thousand Pesos (Php 5,000.00);

**WHEREAS**, the two bidders namely: Grit Laboratory Furnitures and Equipment Corporation and Prince Valiant International Corporation submitted their bid proposals containing the technical and financial documents on August 11, 2024 and August 12, 2024, respectively;

**WHEREAS**, during the **Opening of Bids on August 12, 2024 @ 10:01 am**, the BAC, upon the recommendation of the TWG for Laboratory related Supplies and Equipment, declared the bids of Grit Laboratory Furnitures and Equipment Corporation as **“ineligible”** and declared the bids of Prince Valiant International Corporation as **“eligible”** and passed the technical evaluation of the bidding.

**WHEREAS**, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Prince Valiant International Corporation as **“non-complying”**.

**WHEREAS**, on August 13, 2024, Prince Valiant International Corporation filed a motion for Reconsideration on the BAC decision citing all the circumstances transpired during the bid opening.

**WHEREAS**, on August 19, 2024, the BAC convened to resolved the Motion for Reconsideration of Prince Valiant International Corporation and unanimously decided to grant the Motion for Reconsideration through BAC Resolution No. 579.

**WHEREAS**, on the same day, August 19, 2024, the BAC re-evaluated the financial proposal of Prince Valiant International Corporation and declared its bid proposal **“non-complying”** in the amount of **Two Million, One Hundred Fifty Thousand Philippine Pesos (PHP 2,150,000.00)** and further proclaimed as the Single Calculated Bidder and the bids as calculated are as follows:







**WHEREAS**, the TWG for Laboratory related supplies and equipment, upon the conduct of online **Post-Qualification Evaluation** by the Post Qual Team on **September 4, 2024**, recommended to the BAC to declare the bid of **Prince Valiant International Corporation** as complying and declared as the **Single Calculated and Responsive Bid (SCRB)** for the project: **Upgrading of Laboratory Facilities of the College of Agriculture – Lot 1 – Laboratory Equipment**;

**WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED** that the Bids and Awards Committee hereby recommends to declare the bids of **Prince Valiant International Corporation** as **Single Calculated and Responsive Bid (SCRB)** and to recommend for approval by the University President an award of contract in the total amount of **Two Million, One Hundred Fifty Thousand Philippine Pesos (PHP 2,150,000.00)** and to tasked the BAC Secretariat to post Lot 2 – ICT Equipment for re-bidding in PhilGEPS pursuant to Section 36 of the revised IRR of RA No. 9184:


