WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) on August 30, 2023, to September 6, 2023, for the bidding of Purchase of One (1) Unit Coaster Vehicle (Mini-Bus) for Kalinga State University -Second Bidding with an Approved Budget for the Contract (ABC) amounting to Four Million Philippine Pesos (Php 4,000,000.00) sourced from Internally Generated Fund (IGF) for CY 2023 and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, three (11) prospective bidders, namely Elite North AutoCars, Inc., Areza Motor Sales, Mayo Trece Waste Management and Trucking Services, Inc., Intermobility C., Ltd., Alpine Motors Corporation, Motormall NCR Incorporated, B.M. Domingo Motor Sales Inc.-Bulacan, Amarantha Lotus Inc., Genesis Auto Corp., Auto Global Inc., and Nissan Commonwealth Inc. (Baliwag Branch) browse/read the opportunity at the sites mentioned above, and downloaded the bidding documents:

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Vehicles (TWG-Vehicles) conducted the **Pre-bid Conference** simultaneously via Google Meet Link: **meet.google.com/vnr-mugp-cov**, with the bidder's representatives on **September 7**, **2023**, @ **1 pm** whereupon **Supplemental Bid/Bulletin (SBB) No. 01** dated 12 September 2023 was issued to amend the contents of bidding documents, particularly on Item and Description of Technical Specifications of the project:

**WHEREAS**, as per records of the BAC Secretariat, only one (1) bidder, namely: Genesis Auto Corp., purchased the bidding documents on September 7, 2023;

**WHEREAS**, one (1) bidder, namely: Genesis Auto Corp., had submitted its bidding proposal containing the technical and financial documents before the scheduled time;

WHEREAS, during the Opening of Bids on September 19, 2023, the BAC, upon the recommendation of the TWG for Vehicles, declared the bids of Genesis Auto Corp. as "eligible" and passed the technical evaluation of the bidding

**WHEREAS**, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Genesis Auto Corp. as "**complying**" and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:
