



A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF A CONTRACT FOR THE PROCUREMENT OF CY 2023 IGI FUNDED ICT EQUIPMENT MODERNIZATION PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on December 21, 2023, to January 10, 2024, for the bidding of Procurement of CY 2023 IGI-Funded ICT Equipment Modernization with an Approved Budget for the Contract (ABC) amounting to Twenty-Six Million, Nine Hundred Sixty Thousand Philippine Pesos (Php 5,530,885.00) sourced from Internally Generated Fund (IGF) for CY 2023 and posted the same at the KSU Website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, twenty-eight (28) **prospective bidders**, namely Xitrix Computer Corporation, Joneco Tech Marketing Corporation, Cosmic Technologies Incorporated, DCI International I.T. Solutions and Services Corporation, Micromedia Technologies, Mtechnik Information technology Solutions, LSI Leading Technologies Incorporated, Cosmotech Philippines Incorporated, Power Mac Center Incorporated, Tricom Dynamics Incorporated, Enjcorp Asia Incorporated, Philcomp Computer Center, AG Datacom Phils Incorporated, Brother International Philippines Corporation, Need Ink Sales and Services, Dona Alejandra Incorporated, Amazing Computer Systems and Enterprises, Datacore Technologies Incorporated, GNF General Merchandise, Providers Multi-purpose Cooperative, Photo City, Juan Book Store, MBPS Cabling Corporation, Hexatronixs Marketing, Plus 9 General Merchandise, P and P Medical Supplies and General Merchandise, Alejandra Enterprises and Xworks Sales and Services Incorporated browse/read the opportunity at the sites mentioned above, and downloaded the bidding documents;

WHEREAS, the BAC Secretariat issued **Supplemental Bid/Bulletin (SBB) No. 01** dated December 29, 2023 to amend the contents of bidding documents particularly to the Terms and Conditions and the Notes in the Checklist of Requirements of Technical and Financial Documents.

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for IT Related Supplies and Equipment conducted the **Pre-bid Conference** simultaneously via Google Meet Link: meet.google.com/jfx-zygn-ycm, with the bidder's representatives on **December 29, 2023, @ 10:00 am**;

WHEREAS, as per records of the BAC Secretariat, only one (1) bidder, namely: Philcomp Computer Center, purchased the bidding documents on January 5, 2024;

WHEREAS, one (1) bidder, namely: Philcomp Computer Center, had submitted its bidding proposal containing the technical and financial documents before the scheduled time on January 10, 2024 @ 10:00 am;

WHEREAS, during the **Opening of Bids** on **January 10, 2024 @ 10:01 am**, the BAC, upon the recommendation of the TWG for IT-related Supplies and Equipment, declared the bids of Philcomp Computer Center as **"eligible"** and passed the technical evaluation of the bidding;

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Philcomp Computer Center as **"complying"** and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for IT-related Supplies and Equipment, hereby **recommends for the approval by the University President to declare the bid of Philcomp Computer Center as Single Calculated Responsive Bid (SCRB) and to award the contract amounting to Four Million, Eight Hundred Sixty-Nine Thousand Four Hundred Forty Philippine Pesos (Php 4,869,440.00) for the Procurement of CY 2023 IGI-Funded ICT Equipment Modernization.**

RESOLVED FINALLY to post this Resolution at the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.



 - [] *Section 35.1(c), 2016 R-IRR of RA 9184:* All bids failed to post qualify.
 - [] *Section 35.1(d), 2016 R-IRR of RA 9184:* Someone post-qualified but refused without justifiable cause to accept the award.
