A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF A CONTRACT FOR THE PROCUREMENT OF FIELD AND LABORATORY EQUIPMENT FOR CIVIL ENGINEERING, ELECTRICAL ENGINEERING AND AGRICULTURE AND BIO-SYSTEMS ENGINEERING PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) on November 8, 2023, to November 15, 2023, for the bidding of Procurement of Field and Laboratory Equipment for Civil Engineering, Electrical Engineering and Agriculture and Bio-systems Engineering with an Approved Budget for the Contract (ABC) amounting to Twenty-Six Million, Nine Hundred Sixty Thousand Philippine Pesos (Php 26,960,000.00) sourced from Trust Receipt Fund (TRF) for CY 2023 and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, twenty-eight (28) prospective bidders, namely State Alliance Enterprises Inc., CIFRA Marketing Corporation, Chomar Unitrade Services Co. Ltd., MDCS Mechanical Design and Control System, Shimadzu Philippine Corporation, Innovative Concept Marketing, Prexiphil Corporation, Hytec Power, Inc., Redgutz Trading, Prince Valiant Int'l Corp., West Point Engineering Supplies Incorporated, Macare Medicals, Inc., Krypton International Resources Sales & Services Inc., Zammeds Medical System Inc., Velca Equipment and Engineered Products, Inc., Shiv Dial Sud and Sons. Andsons Educational Resources inc.,Gryke Scientific Instruments Trading, Emmantech Enterprises, Hexatronics Marketing, Siccion Marketing, Inc., LR Marketing, GNF General Merchndise, Unotronix Inc., Humil International Trading, Mars Laboratory Instruments Center, Sciencestar Corporation, Lase Laboratory Equipment Trading browse/read the opportunity at the sites mentioned above, and downloaded the bidding documents;

WHEREAS, the BAC Secretariat issued Supplemental Bid/Bulletin (SBB) No. 01 dated November 13, 2023 to amend the contents of bidding documents particularly to the new schedule of procurement activities, the pre-bid conference, submission of bid proposals, and bid opening will be re-scheduled due to inability to establish the required quorum.

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for IT Related Supplies and Equipment conducted the **Pre-bid Conference** simultaneously via Google Meet Link: meet.google.com/cmn-aoih-jqy, with the bidder's representatives on **November 22**, 2023, @ 10:00 am;

WHEREAS, as per records of the BAC Secretariat, only one (1) bidder, namely: State Alliance Enterprises Inc, purchased the bidding documents on November 23, 2023;

WHEREAS, one (1) bidder, namely: State Alliance Enterprises Inc., had submitted its bidding proposal containing the technical and financial documents before the scheduled time;

WHEREAS, during the Opening of Bids on December 4, 2023, the BAC, upon the recommendation of the TWG for IT-related Supplies and Equipment, declared the bids of State Alliance Enterprises, Inc. as "eligible" and passed the technical evaluation of the bidding:

WHEREAS, the TWG recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of State Alliance Enterprises, Inc. as "**complying**" and further proclaimed as the Single Calculated Bidder. The bids, as calculated, are as follows:
