#### BAC Resolution No. 483 Series of 2024

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid in the PhilGEPS Website (https://notices.philgeps.gov.ph/) on June 28, 2024 to July 9, 2024, for the bidding of Purchase and Delivery of Library Books – Second Bidding with an Approved Budget for the Contract (ABC) amounting to One Million Two Hundred Fifty-Eight Thousand Four Hundred Thirteen Philippine Pesos (Php 1,258,413.00) sourced from Internally Generated Fund (IGF) for CY 2024 and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, six (6) prospective bidders, namely:Mind Mover Publishing House,Inc., Belview Co.,Inc., C&E Publishing Inc., Great Books Trading, New Day Publisher, and Forefront Book Co.,Inc. browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Books/Library Equipment conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/kox-bdut-ofd, with the bidder's representatives on July 10, 2024 (Wednesday) @ 10 am wherein no Supplemental Bid/Bulletin (SBB) issued;

WHEREAS, one (1) bidder/s, namely: Great Books Trading have purchased the bidding documents amounting to Five Thousand Pesos (Php 5,000.00) with an Official receipt No.890820 dated July 11, 2024;

WHEREAS, the lone (1) bidder, namely: Great Books Trading, submitted their bid documents containing the technical and financial documents on July 17, 2024 @ 3 pm, through courier;

WHEREAS, during the Opening of Bids on July 22, 2024, the BAC, using the "pass/fail" criteria, rated Great Books Trading as "eligible" and passed the technical evaluation of the bidding.

WHEREAS, the TWG Books/Library Equipment recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Great Books Trading as "complying", in the amount of One Million, Two Hundred Forty-Seven Thousand, Eight Hundred One Philippine Pesos (1,247,801.00) as the Single Calculated Bid (SCB) as Read as follows:
