**A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND  
RECOMMENDING FOR AWARD OF CONTRACT FOR THE CONCRETING  
OF ROAD NETWORK PHASE XIII PURSUANT TO THE REVISED 2016  
IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO.  
9184**

**BAC Resolution No.471  
Series of 2024**

**WHEREAS**, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) from June 21, 2024 to July 3, 2024, for the bidding of **Concreting of Road Network Phase XIII/ IB\_CivilWorks\_2024-06-049** with an Approved Budget for the Contract (ABC) amounting to **Eight Million, One Hundred Eleven Thousand, Five Hundred Fifty-five Philippine Pesos and Twenty Centavos (Php 8,111,555.20)** sourced from Internally Generated Fund (IGF) for CY 2024, and posted the same at the KSU Website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

**WHEREAS**, in response to the said posting/advertisement, eight (8) prospective bidders, namely: DELTA JO Construction (DELCONS), JAG Four Construction, AZ General Merchandizing, GNF General Merchandise, M.C. Taguba Construction, Double-D Construction, VL Hardware and Construction Supply, JM Lagansi Construction and Supplies, browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

**WHEREAS**, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference simultaneously via Google Meet Link: [meet.google.com/inv-vpss-etk](https://meet.google.com/inv-vpss-etk), with the bidder's representatives on July 4, 2024 @ 10 am whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated July 8, 2024 was issued to amend the contents of bidding documents, particularly on the Bid Data Sheet;

**WHEREAS**, only one (1) bidder, namely: First Reliable Builders, purchased the bidding documents on June 22, 2024;

**WHEREAS**, during the **Submission and Receipt of Bids on July 16, 2024**, through its BAC Secretariat, received one (1) sealed envelope from First Reliable Builders containing the technical and financial documents before the scheduled time;

**WHEREAS**, during the **Opening of Bids** on the same day, **July 16, 2024, @ 10:01 am**, the BAC pursuant to Section 30 of the RA 9184 used a non-discretionary pass/fail criterion, and upon the recommendation of the TWG-Infrastructure, declared the bids of First Reliable Builders as **"eligible"** and passed the technical evaluation of the bidding;

**WHEREAS**, the TWG-Infrastructure recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids First Reliable Builders as **"complying"** and further declared its bid as the **Single Calculated Bid (SCB)** with an amount of **Eight Million, One Hundred Four Thousand, Eight Hundred Forty Philippine Pesos and Forty-Eight Centavos (Php 8,104,840.48)**, inclusive of all government taxes, and other fees and charges, subject to the conduct of post-qualification evaluation and the bids as read are as follows:




**WHEREAS**, on July 22, 2024 at 1 pm the BAC and TWG-Infrastructure, conducted of **Post-Qualification Evaluation Meeting** to consider and adopt the previous Post Qualification Evaluation to the same bidder for the project- Concreting of Road of Bulanao Campus as reference considering of the same project in the proviso that the TWG will re-validate and confirm the report based on the requirements of the new project, if the legal, technical, and financial capabilities of the lone bidder have not changed.

**WHEREAS**, based on its **review of the composite Post Qualification Team Report** that included ascertaining the said bidder's compliance with the legal, financial and technical requirements pursuant to Section 34.3 of the 2016 IRR of RA 9184, the BAC rated the bid of **First Reliable Builders** as **"post-qualified"** for passing all the criteria for post-qualification, and was accordingly declared as the bidder with **"Single Calculated and Responsive Bid (SCRB)"**;

**WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED**, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure, **hereby recommends for approval by the University President to declare the bid of First Reliable Builders as Single Calculated and Responsive Bid (SCRB) and to award the contract amounting to Eight Million, One Hundred Four Thousand, Eight Hundred Forty Philippine Pesos and Forty-Eight Centavos (Php 8,104,840.48) for the project: Concreting of Road Network Phase XIII.**

**RESOLVED FINALLY** to post this Resolution on the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.
