A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE CONSTRUCTION OF FOOD AND TECHNOLOGY INNOVATION CENTER AT RIZAL CAMPUS-SECOND BIDDING PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

BAC Resolution No. 760 Series of 2023

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) from October 4, 2023, to October 11, 2023, for the bidding of Construction of Food and Technology Innovation Center at Rizal Campus-Second Bidding with an Approved Budget for the Contract (ABC) amounting to Seven Million, Seven Hundred Sixty-Eight Thousand, One Hundred Forty-Seven Philippine Pesos and Sixty-Seven Centavos (Php 7,768,147.67) sourced from Internally Generated Income (IGI) Fund for CY 2022, and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days after its first failed bidding which was conducted from September 7, 2023 to September 27, 2023;

WHEREAS, in response to the said posting/advertisement, four (4) prospective bidders, namely: M.C. Taguba Construction, VL Hardware and Construction Supply, Rose Ann Construction and General Merchandise, and Balligi Construction and Development Corporation, browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/ gka-ptno-oeo, with the bidder's representatives on October 12, 2023 @ 10 am whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated October 17, 2023 was issued to amend the contents of bidding documents, particularly on the Bid Data Sheet and Technical Specification;

WHEREAS, only two (2) bidders, namely: Balligi Construction and Development Corporation and Rose Ann Construction and General Merchandise, purchased the bidding documents on October 11, 2023, and October 17, 2023, respectively;

WHEREAS, during the Submission and Receipt of Bids on October 24, 2023, Balligi Construction and Development Corporation and Rose Ann Construction and General Merchandise submitted their bid documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the Opening of Bids on the same day, October 24, 2023, @ 10:01 am, the BAC, upon the recommendation of the TWG-Infra, declared the bids of Balligi Construction and Development Corporation and Rose Ann Construction and General Merchandise as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids of Balligi Construction and Development Corporation and Rose Ann Construction and General Merchandise as "complying" and further declared the bid of Rose Ann Construction and General Merchandise as the Lowest Calculated Bid with an amount of Seven Million, One Hundred Thirty-Nine Thousand Two Hundred Eighty-Seven Philippine Pesos and Twenty-Five Centavos (Php 7,139,287.25) subject to the conduct of post-qualification evaluation and the bids as calculated are as follows:

RESOLVED FINALLY to post this Resolution on the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.
