A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE CONSTRUCTION OF POWER HOUSE AND SUPPLY AND INSTALLATION OF GENERATOR SET PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

BAC Resolution No. 237 Series of 2024

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) from March 8, 2024 to April 2, 2024, for the bidding of Construction of Power House and Supply and Installation of Generator Set with an Approved Budget for the Contract (ABC) amounting to One Million, Three Hundred Twelve Thousand, One Hundred Twenty-Eight Philippine Pesos and Sixty-Three Centavos (Php 1,312,128.63) sourced from Internally Generated Fund (IGF) for CY 2023, and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, thirteen (13) prospective bidders, namely: Indentrade Systems Corporation, Delta Jo Construction (DELCONS), www construction, MZNPower Enterprise, Rose Ann Construction and General Merchandise, VL Hardware & Construction Supply, Fil Generators and Services Company, Blessedmontero General Merchandise, Shakesville Enterprises, Trade Venture International Corporation, Budz Electrix and Construction Services, Edwin S. Santiago Enterprise Corporation and All Certified Equipment Trading Corporation browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC), the Technical Working Group for Infrastructure Projects (TWG-Infra) and TWG for Electrical Supplies and Equipment conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/thy-rngx-cvw, with the bidder's representatives on March 21, 2024 @ 10 am whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated March 25, 2024 was issued to amend the contents of bidding documents, particularly on the project requirements;

WHEREAS, only one (1) bidder, Rose Ann Construction and General Merchandise, purchased the bidding documents on March 26, 2024;

WHEREAS, during the Submission and Receipt of Bids on April 2, 2024, only Rose Ann Construction and General Merchandise, submitted its bid documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the Opening of Bids on the same day, April 2, 2024 @ 10:01 am, the BAC, upon the recommendation of the TWG-Infra, declared the bids of Rose Ann Construction and General Merchandise as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra and TWG for Electrical Supplies and Equipment recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids of Rose Ann Construction and General Merchandise as "complying", and further declared its bid as the Single Calculated Bid with a bid amount of One Million Three Hundred Six Thousand Nine Hundred Six Pesos (Php 1,306,906.00) subject to the conduct post-qualification evaluation;

WHEREAS, the TWG-Infra and TWG for Electrical Supplies and Equipment, upon the conduct of **Post-qualification Evaluation** by the Post Qual Team on April 11, 2024, recommended to the BAC to declare the bid of Rose Ann Construction and General Merchandise as the **Single Calculated and Responsive Bid (SCRB)**;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infrastructure Projects and TWG for Electrical Supplies and Equipment, hereby recommends for approval by the University President to declare the bid of Rose Ann Construction and General Merchandise as Single Calculated and Responsive Bid (SCRB) and to award the contract amounting One Million, Three Hundred Six Thousand, Nine Hundred Six Philippine Pesos (Php 1,306,906.00) for the project: Construction of Power House and Supply and Installation of Generator Set.

RESOLVED FINALLY to post this Resolution on the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.

- [] Section 35.1(c), 2016 R-IRR of RA 9184: All bids failed to post qualify.
- [] *Section 35.1(d), 2016 R-IRR of RA 9184:* Someone post-qualified but refused without justifiable cause to accept the award.

[] SUBJECT FOR RE-BID based on the following:

- [] *Section 35.2, 2016 R-IRR of RA 9184:* Task the BAC and TWG to conduct a mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.
- [] *Section 35.3, 2016 R-IRR of RA 9184:* To task the BAC to conduct a re-bidding with readvertisement and/or posting.
- [] *Section 35.5, 2016 R-IRR of RA 9184:* To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).
