A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE UPGRADING OF ELECTRICAL LINES TO 3-PHASE OF KSU RIZAL CAMPUS PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

BAC Resolution No. 470 Series of 2024

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid on the PhilGEPS Website (https://notices.philgeps.gov.ph/) from June 21, 2024, to July 3, 2024, for the bidding of Upgrading of Electrical Lines to 3-Phase of KSU Rizal Campus with an Approved Budget for the Contract (ABC) amounting to Two Million, Eight Hundred Eighty-Five Thousand, Two Hundred Seventeen Philippine Pesos and Twenty-Four Centavos (Php 2,885,217.24) sourced from Internally Generated Fund (IGF) for CY 2024, and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, seven (7) prospective bidders, namely: AsiaPhil. Incorporated, HOM-COR Marketing & Construction Services Corporation, Automation Specialist and Power Exponents, Inc., Delta Jo Construction (DELCONS), Budz Electrix and Construction Services, AZ General Merchandizing, and M.C. Taguba Construction, browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC) and the TWG for Electrical Related Supplies & Equipment conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/npd-famr-ymm, with the bidder's representatives on July 4, 2024 @ 1:00 pm whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated July 8, 2024 was issued to amend the contents of bidding documents, particularly on the Bid Data Sheet;

WHEREAS, only one (1) bidders, namely: Joel U. Acosta Electrical Services, purchased the bidding documents on July 4, 2024;

WHEREAS, during the Receipt Bids on July 16, 2024, Joel U. Acosta Electrical Services submitted its bid documents containing the technical and financial documents before the scheduled time:

WHEREAS, during the Opening of Bids on the same day, July 16, 2024, @ 1:01 pm, the BAC pursuant to Section 30 of the RA 9184 used a non-discretionary pass/fail criteria, and upon the recommendation of the TWG for Electrical Related Supplies & Equipment, declared the bids of Joel U. Acosta Electrical Services as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG for Electrical Related Supplies & Equipment recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids of Joel U. Acosta Electrical Services as "complying" and further declared its bid as the Single Calculated Bid with an amount of Two Million Eight Hundred Eighty-Three Thousand and Fifteen Philippine Pesos (PHP 2,883,015.00), inclusive of all government taxes, and other fees and charges, subject to the conduct of post-qualification evaluation and the bids as calculated are as follows:
