

CONTRACT AGREEMENT

CONTRACT NO.: 2024-01-001_IB_GOODS

THIS AGREEMENT made this 15th day of January 2024 between KALINGA STATE UNIVERSITY of Kalinga Province hereinafter called "the Entity" of the one part and CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS INC. with office address at the New Street Bldg., Mac Arthur Highway, Balibago, Angeles City, Pampanga hereinafter called "the Supplier" of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., "PROCUREMENT OF INTERNET SUBSCRIPTION FOR KSU DAGUPAN AND RIZAL CAMPUS" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of TWO MILLION SEVEN HUNDRED NINETY THOUSAND PHILIPPINE PESOS (PHP 2,790,000.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

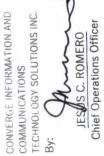
- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted *e.g.* bidder's response to clarifications on the bid, including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
