A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE CONSTRUCTION OF COVERED THIRD FLOOR OF CLASS BUILDING DAGUPAN CAMPUS – REDESIGNED PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 934
Series of 2023**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) from November 16, 2023, to November 23, 2023, for the bidding of for **Construction of Covered Third Floor of CLASS Building Dagupan Campus – Redesigned** with an Approved Budget for the Contract (ABC) amounting to **Nine Hundred Seventy Thousand, Eight Hundred Seventy-Three Philippine Pesos and Seventy-Nine Centavos (Php 970,873.79)** sourced from Internally Generated Income/(IGI) Fund for CY 2022, and posted the same at the KSU Website (<https://ksu.edu.ph/>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, two (2) prospective bidders, namely: DELTA VL HARDWARE & CONSTRUCTION SUPPLY and M.C. TAGUBA CONSTRUCTION, browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference simultaneously via Google Meet Link: **meet.google.com/byg-qvpy-jze**, with the bidder's representatives on November 24, 2023 @ 10 am;

WHEREAS, Supplemental Bid/Bulletins (SBB) No. 01, dated December 4, 2023, was issued to amend the contents of bidding documents, particularly on the schedule of Bid Opening. The President released an advisory instructing all the Permanent Non-Teaching Personnel to attend the orientation program for new entrants on December 6, 2023.

WHEREAS, the Bids and Awards Committee hereby moved the schedule of the receipt and opening of the bid for the above project on December 7, 2023;

WHEREAS, only one (1) bidder, First Reliable Builders, purchased the bidding documents on December 7, 2023 @ 9:01 am;

WHEREAS, during the **Submission and Receipt of Bids on December 7, 2023**, only First Reliable Builders submitted its bid documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the **Opening of Bids** on the same day, **December 7, 2023, @ 10:01 am**, the BAC, upon the recommendation of the TWG-Infra, declared the bids of First Reliable Builders as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids **First Reliable Builders** as "complying" and further declared its bid as Single Calculated Bid with an amount of **Nine Hundred Sixty-Seven Thousand, One Hundred Forty-Two Philippine Pesos and Fifty-One Centavos (Php 967,142.51)** subject to the conduct post-qualification evaluation and the bid as calculated are as follow:



WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infra, **hereby recommends for approval by the University President to declare the bid of First Reliable Builders as Single Calculated and Responsive Bid (SCRB) and to award the contract amounting to Nine Hundred Sixty-Seven Thousand, One Hundred Forty-Two Philippine Pesos and Fifty-One Centavos (Php 967,142.51) for the project: Construction of Covered Third Floor of CLASS Building Dagupan Campus – Redesigned.**

RESOLVED FINALLY to post this Resolution on the PhilGEPS and KSU Websites and conspicuous places on the University's premises, including the BAC Bulletin Board, for transparency and information purposes.
