A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDERS AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE PURCHASE AND DELIVERY OF ICT EQUIPMENT FOR BAMBOO PROJECT PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the Kalinga State University (KSU) published the Invitation to Bid in the PhilGEPS Website (https://notices.philgeps.gov.ph/) on July 26, 2024 to August 19, 2024, for the bidding of Purchase and Delivery of ICT Equipment for Bamboo Project"/ IB_Goods_2024-07-065 with an Approved Budget for the Contract (ABC) amounting to One Million Ten Thousand Two Hundred Fifty Philippine Pesos (Php 801,671.58) sourced from Regular Agency Fund (RAF) for CY 2024 and posted the same at the KSU Website (https://ksu.edu.ph), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days,;

WHEREAS, in response to the said posting/advertisement, twenty (20) prospective bidders, namely:GRSoriano Consumer Goods Wholesaling, GNF General Merchandise, Need Ink Sales and Services, Xitrix Computer Corporation, DCI Int'l. I.T. Solutions and Services, AEC Techno World, Tarlac MAC Enterprises, Inc. Doing Business Under the Name and Style of First AC Mega Saver and First MAC Megasaver, LSI Leading Technologies Inc., Philcomp Computer Center, Micromedia Technologies, Shock and Awe Industrial Corp., Hinoki Global Concepts Inc., EMP Global Technology Product Inc., Alejandra Enterprises, Lightnet Connect Systems Corp., Hayden General Merchandise, Hytec Power, Inc. Hayford Office Supplies and Equipment Trading, Rmelgarejo Pharma and Medical Supplies Trading, and J and G General Merchandise browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, one (1) bidder, namely: Philcomp Computer Center, submitted its bid documents containing the technical and financial documents on August 19, 2024;

WHEREAS, during the Opening of Bids on August 19, 2024, the BAC, using the "pass/fail" criteria, rated GRSoriano Consumer Goods Wholesaling and Rose Ann Construction and General Merchandise as "eligible" and passed the technical evaluation of the bidding.

WHEREAS, the TWG IT-Related Supplies and Equipment recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of Philcomp Computer Center as "complying", as Read as follows:
