



A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDERS AND RECOMMENDING FOR AWARD OF CONTRACTS FOR NEGOTIATED PROCUREMENT OF SUPPLIES, MATERIALS AND EQUIPMENT FOR CAFFEINE PROJECT PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 583
Series of 2024**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid in the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) on July 25-30, 2024, for the bidding of **Negotiated Procurement of Supplies, Materials and Equipment for Caffeine Project** with an Approved Budget for the Contract (ABC) amounting to **One Million Ten Thousand Two Hundred Fifty Philippine Pesos (Php 1,010,250.00)** sourced from Trust Receipt Fund (TRF) for CY 2024 and posted the same at the KSU Website (<https://ksu.edu.ph>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days after its two-failed bidding on March 13, 2024 and April 8, 2024, respectively,;

WHEREAS, in response to the said posting/advertisement, **five (5) prospective bidders**, namely:GRSoriano Consumer Goods Wholesaling, Lase Laboratory Equipment Trading, GNF General Merchandise, A7 Enterprises Inc. and Need Ink Sales and Services browsed/read the opportunity at the sites mentioned above and downloaded the bidding documents;

WHEREAS, two (2) bidders, namely: GRSoriano Consumer Goods Wholesaling and Rose Ann Construction and General Merchandise, submitted their bid documents containing the technical and financial documents on July 30, 2024;

WHEREAS, during the **Opening of Bids on July 30, 2024**, the BAC, using the “pass/fail” criteria, rated GRSoriano Consumer Goods Wholesaling and Rose Ann Construction and General Merchandise as **“eligible”** and passed the technical evaluation of the bidding.

WHEREAS, the TWG Supplies and Materials and TWG for Electrical Related Supplies and Materials recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bid of GRSoriano Consumer Goods Wholesaling and Rose Ann Construction and General Merchandise as **“complying”**, as Read as follows:

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the TWG Supplies and Materials and TWG for Electrical Related Supplies and Materials, hereby **recommends for approval by the University President to declare the bids of Rose Ann Construction and General Merchandise as Single Calculated Responsive Bid and to award the contracts amounting to Eight Hundred Twelve Thousand, Fifty-Eight Philippine Pesos (Php 812,058.00) for Lot 1 and Lot 2 and GRSoriano Consumer Goods Wholesaling amounting to One Hundred Fifty-Nine Thousand Four Hundred Thirty-Three Philippine Pesos (Php 159,433.00) for Lot 3.**

RESOLVED FINALLY to post this Resolution at the PhilGEPS and KSU Websites and conspicuous places at the University's premises, including the BAC Bulletin Board, for transparency and information purposes.


